Terms and conditions - Model release

By uploading one or more images to the Lindemans Summer Search site, I also certify that I am the copyright owner of the image/s.

I'm aware of the fact that the image/s may be used for marketing, information or advertising purposes – both online and offline – Therefore, I also certify that I have a model release – an agreement between me and any person in the image/s – that does not prohibit me from uploading the image/s.

In clear writing: A person in any photo being uploaded by you to this site, must have given consent to be photographed and to the use mentioned above of the images.

If the person is under 18 years old, the parent/legal guardian of the same person must give his/her permission.

Information we may collect

We may collect information that can identify you ("personal information"), such as your name and email address, when you (or other users) provide it to us when using our website. We may combine the personal information that we receive from different sources.

We also may collect other types of information in the following ways when you visit our website:

Our server logs automatically collect information, such as your IP address, your browser type and language, and the date and time of your visit, which helps us track users' movements around our site and understand trends.

We may assign your computer one or more cookies which may collect information to facilitate access to our website and to personalize your online experience.

We may use standard Internet tools, such web beacons, which collect information that tracks your use of our website and enables us to customize our services and advertisements.

We do not knowingly collect personal information from anybody under the age of 20.

How We May Use Information We Collect

We may use information to:

Fulfill your requests for products and services;

Offer products and services that may be of interest to you;

Process payment for products or services you order via our website;



Customize the advertising and content that you see on our website;

Facilitate use of our website;

Manage your account and your preferences;

Analyze use of and improve our website, products and services;

Identify and protect against fraudulent transactions and other misuses of our website; and

Enforce our Terms of Use.

With whom we may share information we collect

We will not share your personal information with others except as indicated below, or except when we inform you in advance and give you the opportunity to opt out. We may share personal information with:

Service providers, such as credit-card payment processors, performing services on our behalf;

Other Treasury Wine Estates businesses;

Other third parties in limited circumstances, such as complying with legal requirements, preventing fraud, and protecting the safety of our users.

We may share aggregated, non-personal information in any of the above situations.

Your choices

You may choose:

Not to provide personal information, although that may result in your inability to obtain certain services or use certain features of our website;

To delete or decline cookies by changing your browser settings, although if you do so, some of the features or services of our website may not function properly;

Security

We take appropriate physical, electronic, and other security measures to help safeguard personal information from unauthorized access, alteration, or disclosure.

Cookies: A cookie is a small text file that is stored on a user's computer for record keeping purposes. Cookies can be either session cookies or persistent cookies. A session cookie expires when you close your browser and is used to make it easier for you to navigate our website. A persistent cookie remains on your hard drive for an extended period of time.

For example, when you sign in to our website, we will record your user or member ID and the name on your user or member account in the cookie file on your computer. We also may record your password in this cookie file, if you indicated that you would like your password saved for automatic sign-in. For security purposes, we will encrypt any usernames, passwords, and other user or member account-related data that we store in such cookies. In the case of sites and services that do not use a user or member ID, the cookie will contain a unique identifier. We may allow our authorized service providers to serve cookies from our website to allow them to assist us in various activities, such as doing analysis and research on the effectiveness of our site, content and advertising.

You may delete or decline cookies by changing your browser settings. (Click "Help" in the toolbar of most browsers for instructions.) If you do so, some of the features and services of our website may not function properly.

We may allow third-parties, including other Treasury Wine Estates companies, advertising companies, and ad networks, to display advertisements on our site. These companies may use tracking technologies, such as cookies, to collect information about users who view or interact with their advertisements. Our website does not provide any personal information to these third parties, but they may collect information about where you, or others who are using your computer, saw and/or clicked on the advertisements they deliver, and possibly associate this information with your subsequent visits to the advertised websites. They also may combine this information with personal information they collect from you. The collection and use of that information is subject to the third-party's privacy policy.
